# Notice Regarding Change of Consolidated Second-Tier Subsidiaries (Capital Increase)

Belluna Co., Ltd. (the "Company") hereby announces that it resolved at the meeting of the board of directors held on April 11, 2017 that its consolidated subsidiary, BELUNA LANKA PVT. LTD, would increase capital stock of the second-tier subsidiaries of the Company, UNION PLACE APARTMENTS PVT. LTD and MARINE DRIVE HOTELS PVT. LTD, as follows.

#### Description

#### 1. Reason for the change

The BELLUNA Group has decided to increase its capital to expand the property business in the Democratic Socialist Republic of Sri Lanka for the purpose of diversified investment of assets and monetization.

With this capital increase, the amount of capital stock of those second-tier subsidiaries, namely UNION PLACE APARTMENTS PVT. LTD and MARINE DRIVE HOTELS PVT. LTD, will be ten hundredths or more of the capital stock of the Company and accordingly become the specified subsidiary of the Company.
